Unsealed bids will not be honored or accepted. Bid shall be an actual dollar amount. In the event of a tie of winning bid, the tied winning bidders will be asked to submit another bid in a dollar amount no less than their first bid amount. Bids listed as an amount above highest bidder will not be accepted.

The VCCD is not responsible for delays in delivery of bids by USPS, UPS, FedEx, or other means of delivery.

The bid must include the completed bid form located at the end of this document. Bids must be submitted in a sealed envelope, clearly marked **BID 2 Wheel Cart**.

Bids will be publicly opened at **1 p.m. on April 18, 2022** at the White Oak Barn, Kennekuk County Park, 22296 Henning Rd, Danville, IL 61834. Attendance of bidder **is not** required.
