Due to insurance regulations test drive of vehicle is prohibited. Starting the vehicle will be allowed **by appointment**, Monday thru Friday 6 a.m. to 3:00 p.m.

Sealed bids will be received until **11 a.m. on Monday, October 30, 2023** at the Vermilion County Conservation District Administration Building, 22296 Henning Rd, Danville, IL 61834. Unsealed bids will not be honored or accepted. Bid shall be an actual dollar amount. In the event of a tie of winning bid, the tied winning bidders will be asked to submit another bid in a dollar amount no less than their first bid amount. Bids listed as an amount above highest bidder will not be accepted. Information on how many bids have been submitted will not be available until bid opening.

The VCCD is not responsible for delays in delivery of bids by USPS, UPS, FedEx, or other means of delivery.

The bid must include the completed bid form located at the end of this document. Bids must be submitted in a sealed envelope, clearly marked **BID 2007 Ford Ranger Unit # 3**.

Bids will be publicly opened at **1 p.m. on Monday, October 30, 2023** at the White Oak Barn, Kennekuk County Park, 22296 Henning Rd, Danville, IL 61834. Attendance of bidder **is not** required.
