Unsealed bids will not be honored or accepted. Bid shall be an actual dollar amount. In the event of a tie of winning bid, the tied winning bidders will be asked to submit another bid in a dollar amount no less than their first bid amount. Bids listed as an amount above highest bidder will not be accepted. Information on how many bids have been submitted will not be available until bid opening.

The VCCD is not responsible for delays in delivery of bids by USPS, UPS, FedEx, or other means of delivery.

The bid must include the completed bid form located at the end of this document. Bids must be submitted in a sealed envelope, clearly marked **BID M&W 15' Disk**.
