NEW SEALED BID FOREST GLEN

HUNTS FOR 2026

The Vermilion County Conservation District will be auctioning six archery hunts. The hunting area is located in the central portion of the park and divided into two hunting zones. The auction will be ALL SEALED BIDS and you may choose between Zone W or Zone E. Zone W is located on the West side of Group Campground Road just past the gate. Zone E is located on the East side of the road just past the gate. The Earn-a-Buck program *does not apply* to these hunts but it is strongly encouraged that you harvest does. Hunters who win a week may bring ONE extra hunter with them to hunt in the same zone. If the winning bidder approves one hunter to hunt the same week and zone, that hunter will pay the winning bid amount of the hunt to the VCCD prior to the week of the hunt, and is held to all rules of the program.

The Sealed Bids will be opened first thing at the lottery drawing, Monday, July 20 2026. Your bid must be postmarked by July 13, 2026 received by 4:30pm July 17, 2026. The drawing nor the opening of the sealed bids will be open to the public.

Winners will be contacted and must pay the bid in full by 4:30pm July 27, 2026.

All bidders will be notified by email or postal mail. In the event that a hunt week has no bids, that hunt week will be sold on a first-come, first-serve basis for \$1,000 starting August 3 at 8:30am. This will be advertised.
